Runway Fest Update

Building/Grounds Committee:

Land Acquisition Update

An issue has arisen regarding obtaining clear title to the Airport Authority for the land parcel coowed by PACA. Two of the original owners' signatures cannot be secured as they are deceased. President Lucas will forward this issue to the Board's legal counsel, Christopher Meduri for advice on how to proceed. Member Festa has been assigned to this issue once a response from Mr. Meduri is received.

NEW BUSINESS

Real Estate Re-Evaluation

There are 5 Board-owned properties subject to re-evaluation by the County. President Lucas will review the document for appropriate action.

Hangar Funding Opportunities

The members wish to find a way to raise revenue to replace and build new hangars. Member Festa is seeking a plan that will make tax-free revenue bonds available to the public. The Portage County Port Authority has offered to meet with Board members to discuss this endeavor. Members Festa, Paul, Krister, and Burton will comprise the new committee for this purpose.

COMMENTS / ANNOUNCEMENTS

President Lucas:

- The Ohio Aviation Association will be sponsoring General Aviation Day on September 18 in Columbus, Ohio; members are welcome to attend if possible. Tenant Gilmore remarked that Board representation is important at these meetings and workshops to show its interest in aviation procedures, improvements, recommendations, and training.
- County Commissioner Sabrina Bennett advised that there will be County Commissioners Advisory Meeting at the Wayne County Airport on September 24; A tour of the airport will be provided; Board members may attend if possible.
